I agree to be bound by all the terms and conditions outlined on your website, brochures, and documents and all of the following:

1. RESERVATIONS AND CANCELLATIONS: I understand that in order to confirm a reservation, \$1000 is due immediately to reserve a specific date. Within 30 days the balance of the 50% deposit is required with the remaining finalized balance due 60 days prior to arrival in guaranteed funds. I understand deposits are non-refundable, however, they may be transferred to another party or approved hunt date.
2. GENERAL LIABILITY AND INSURANCE: I understand and accept that there are inherent risks in this type of activity. Accordingly, I have read and signed the attached Waiver, Assumption of Risk and Indemnity Agreement which I understand forms part of my hunt contract.
3. GENERAL INFORMATION: I understand that photographs and videos of myself and my fellow hunters may be taken during my hunt and used for promotional purposes without further authorization.
4. WOUND CLAUSE: If an animal is considered wounded and not recovered in a timely manner (determined by your guide), this is considered a kill.
5. I understand and will follow all guidelines set forth by my guide, Trek Outfitting, during my hunt and understand that my hunt can be terminated immediately with any infractions to Trek rules or Alberta hunting regulations. Any additional costs associated with terminated hunts will be at the hunters expense.

WAIVER, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

PLEASE BE AWARE THAT BY SIGNING THIS AGREEMENT YOU GIVE UP THE RIGHT TO SUE FOR INJURY OR DAMAGES WHATSOEVER THE CAUSE.

TREK OUTFITTERS, {hereinafter referred to as, "The Outfitter"} and employees, representatives, officers, agents and volunteers {hereinafter referred to collectively as, "The Outfitters Staff"}

I, _____ hereby sign this agreement on behalf of myself, my personal representatives, heirs and assigns.

I agree as a precondition to my participation in a hunting activity organized by "The Outfitter" and conducted by "The Outfitter" or "The Outfitters Staff", and in further consideration of "The Outfitter" allowing me to do so, to be strictly bound by the terms of this Waiver, Assumption of Risk and Indemnity Agreement {hereinafter referred to as "This Agreement".

I acknowledge that hunting activities involve inherent risks that may cause serious injury and possible death to participants. I further recognize that hunting activities involve additional risks and dangers.

I fully understand the risk and dangers associated with my participation in this hunting activity and accept the same entirely at my own risk.

I hereby waive any and all claims which I may have against "The Outfitter" and the "The Outfitters Staff" and release "The Outfitter" and "The Outfitters Staff" from all liability for injury, death, property damage or any other loss sustained to me as a result of my participation in this hunting activity, due to any cause whatsoever, including without limitation, negligence on the part of "The Outfitter" and the "The Outfitters Staff". I further agree to indemnify "The Outfitter" and "The Outfitters Staff" for any and all legal fees {on a solicitor and his own client basis} or costs which may be incurred defending any lawsuit or claim I bring against them.

I appreciate that "This Agreement" applies whether "The Outfitter" is at fault or not and it limits the liability of "The Outfitters Staff" to the same extent as it limits the liability of "The Outfitter" even though "The Outfitters Staff" are not formal parties to "This Agreement". I understand that "The Outfitter" in securing execution of "This Agreement" by myself, is acting as an agent or trustee on behalf of or for the benefit of "The Outfitters Staff", who shall to this extent be or deemed to be parties to "This Agreement".
